Diana Morefield, ACAN Chair called the meeting order at 9:02 a.m. Adjournment: 10:30 a.m. Attendees introduced themselves and general announcements were made around the room.

### Guest Speakers: Detective Marilyn Rush-Lara Special Agent Sandra Pennington-Colorado Department of Revenue Topic: Scams and ID Theft

- Credit Card, Tax, Bank, Cell Phone and Utilities are the most common types of **ID theft**. (Use credit cards rather than debit cards.)
- Scams: Imposter, Phishing, Debt Collection, Foreclosure relief, loan modification and email fraud.
- **2024-Top Scams**: AI powered, student loan forgiveness, phone, zell or peer to peer payment, romance, employment, and online purchase.

**Tools:** <u>Protect</u> what you have (minimize personal information); Be careful what you share, (Know the person); don't click on links sent in unsolicited emails. <u>Monitor</u>, (Review mail and financial statements); check credit reports. (Annualcreditreport.com); Dispose of property by shredding. Know who is preparing your taxes (AARP will provide services to seniors free or reduced rate.) Do taxes early, take directly to the Post office or use secured online network. Monitor your credit and ID; (Experian has a free credit service.)

Use <u>www.ftc.gov/passiton</u> to provide information about current scams and contact law enforcement if you are scammed. This is important.

<u>Avoid being a victim</u>: <u>Be skeptical</u> when someone contacts you. Have a <u>family password</u> for identification if you receive a telephone scam and <u>verify</u> with family members before giving out information or money. <u>Don't click</u> on unknown links, <u>enable</u> multifactor identification, <u>look for</u> suspicious payment requirements. <u>Hang up</u>, look for a reputable number and call the company back are just a few tips. Many companies will NOT call you!
