# ACAN Membership Meeting Wednesday, August 7, 2024 @ 9:00 a.m. Thornton Community Connections Center 9471 Dorothy Blvd., Thornton, CO

Presentation by Carmen LaPuma Community Engagement and Presence Liaison Adams County Human Resources

Carmen's presentation will cover LEAP and other related programs. LEAP is a federally funded program run by the state of Colorado that helps qualified individuals pay a portion of their home heating costs. Applications are available starting November 1<sup>st</sup> and will end April 30<sup>th</sup>. The average benefit for LEAP this year is just under \$400. Other programs that can help folks with utilities are available. Energy Outreach Colorado is a non-profit that can provide up to \$1000 of relief per year for one gas and one electric bill. Arapahoe and Adams County's Weatherization program and the Crisis intervention Program will be explained. Applications and brochures will be provided.

# Adams County Aging Network Thornton Community Connections Center January 8, 2025

Attendance: 17

Diana Morefield, ACAN Chair called the meeting to order at 9:04 a.m.

Attendees introduced themselves and general announcements were made around the room.

Presentation by Erika Dubray and Jayla Sanchez-Warren from the Denver Regional Council of Governments (DRCOG) Area on Agency

Erika Dubray, Manager - Aging and Disability Resource Center, described the programs and services available to those over age 60 including several also available to disabled adults over age 18. These included: Aging and Disability Resource Center, Information and Assistance, Choice Services Programs (Transportation, In-Home Services), Caregiver Support, Network of Care, Options Counseling, Case Management, Veteran Directed Care, Older Adult Refugees & Friends, Community Options/Transitions, State Health Insurance Assistance, Senior Medicare Patrol, and Ombudsman Programs. The Area Agency on Aging for the Denver Metro Region can be reached at 303-480-6700.

Jayla Sanchez-Warren, Director of the DRCOG Area Agency on Aging, discussed the funding challenges facing our AAA in providing needed services for seniors. Although it had bipartisan support, the Older American's Act was not passed in the US Congress by the end of 2024 thus funding has not yet been approved for the ensuing years. States will not receive any Federal dollars to fund older American's needs until the Act is passed and signed. It is uncertain how the incoming administration will proceed with OAA funding. Concurrently, the State of Colorado is dealing with a large budget shortfall this year and funding for our senior's needs will most likely remain level even though the numbers of those 60+ in this state continues to increase rapidly. Our AAA will be asking all available seniors to help advocate for funding through letters, phone calls and visits to our legislators in the coming months.
